<b>Criteria</b>	<ul style="list-style-type: none"> <li>• Nominee must have earned the Adult and/or Youth Volunteer of the Year award from any Army Installation three (3) times throughout their volunteer service history verifiable through the individual's volunteer service record (DA 4162)</li> <li>• Volunteer is registered in the Volunteer Management Information System (VMIS) and has actively tracked volunteer service hours</li> <li>• Volunteered a minimum of <b>750 hours</b> for the previous calendar year</li> </ul>
