As a CACI background investigator, you'll play a vital role in national security by providing the Federal government with quality investigations on individuals who have applied for a security clearance. Background Investigators work from their home office and create their own schedule. A typical day includes scheduling appointments, conducting interviews at various locations, and typing reports following the interviews.

**Level I positions require either a four-year degree or four years of progressive work experience.** Level 1 investigators can be promoted within 6 months. Full-time Investigators work 40 hours per week, with an hourly wage plus Health and Welfare (H&W) benefits. Investigators receive mileage reimbursement at the current GSA rate.

**Qualified applicants with an active Top-Secret clearance are eligible to begin work in as little as 30 days. Qualified applicants with an active Secret clearance are also eligible and typically start within 60 days upon a SSBI favorable being granted.
