Components	Certificate signed by the 4ID and Fort Carson Commanding General and Command Sergeant Major; Volunteer Pin.	
Approving Authority	Discretion of the Unit, Directorate and Private Organization leadership	
Criteria	<ul> <li>Brigade level Units can recognize up to five (5) of their "own" volunteers quarterly.</li> <li>Tenant Battalions, Directorates and Private Organizations can recognize up to two (2) of their volunteers quarterly.</li> <li>This award is reserved for the Unit/Directorate/Organization's top Volunteers of the Quarter.</li> <li>Submissions by Commander/Director will be selected.</li> <li>No minimum hours are required, but volunteer(s) must be registered in VMIS with hours tracked there as well.</li> <li>Battalions, Directorates and Private Organizations are responsible to submit quarterly packets NLT suspense date for appropriate processing.</li> </ul>
