I also understand Fort Carson Family Advocacy Program does not assume any responsibility or obligation to provide financial assistance, including, but not limited to, medical, health, or disability insurance, in the event of injury, illness death, or property damage.

**Medical Treatment:** I hereby release and forever discharge Fort Carson Family Advocacy Program from any and all claims, demands and causes of action whatsoever that may arise or may hereafter arise on account of any first aid or other medical treatment rendered in connection with this event activities.

**Assumption of Risk:** I understand that my participation for the DVAM 5K Walk/Run (Pause Against Violence) with Fort Carson Family Advocacy Program arranged or promoted by, or otherwise affiliated or associated with my organization may include activities that may be hazardous to me. I further recognize and understand that such participation may involve certain inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in the activities and release Fort Carson Family Advocacy Program from all liability for injury, illness, death and/or property damage that may result.

**Pets:** I understand that my pet's participation in the DVAM 5K Walk/Run (Pause Against Violence) with Fort Carson Family Advocacy Program may be hazardous to my pet(s). I affirm that my pet(s) have been licensed, are current on Rabies and Distemper (DAP) vaccines, and are/will be at least 4 months old at the time of the walk. I hereby expressly and specifically assume the risk of injury or harm to my pet(s) in the activities and release Fort Carson Family Advocacy Program from all liability for injury, illness, death and/or property damage that may result. I agree to keep my pet(s) leashed at all times and clean up any pet waste left by my pet(s). I affirm that my pet is not of an aggressive nature and I will agree to leave the event if my pet(s) shows any aggression to other participants or their pet(s).

**Other:** I expressly understand and agree that this Release is intended to be as broad and inclusive as permitted by law, and that this Release shall be governed and interpreted in accordance with the laws of Colorado. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.
